12.1 Lease Agreement for Bogart Park - Action

Nominations were opened and Mark Balys, Martin Rosen and Hugh Van Horn were nominated to serve as Vice Chair for FY 2015/16.

Mark Balys was elected as Vice Chair of the District Advisory Commission for FY 2015/16. (M/S/C Hake, Christensen)

12.6 7 Mile Box Springs Feeder Trail – Action Scott Bangle, General Manager Job Code 2015-9

GM Bangle reviewed the preliminary disposition process with the Commission.

Various questions were asked by the Commission, which were addressed.

The Commission approved the preliminary disposition process. (M/S/C Rosen, Balys), CM Christensen, abstained

13.0 Commissioners Report – Information

Commissioner Kinne stated that up until recently there was a sign at McCall Park that read "McCall Memorial Park, Equestrian Campground" the new sign has left out the word "Equestrian", this has caused a lot of concern with the Equestrian community.

BC Brown stated that the signs were updated to reflect the change in our fees and the word "Equestrian" was unintentionally left off. The District does plan to allow day use and camping of non-equestrians because the park is not being filled up by equestrians. The District Staff are talking with the equestrians to get their input on where would be the best possible location for non-equestrians so that there is will not be interference with the equestrian campers. At this time no changes will be made to allow non equestrian campers due to the water issue and not having a camphost location on site.

CM Kinne is concerned about the safety of the comingling of non-equestrian with the equestrians.

CM Van Horn inquired about where the liability would be if a non-equestrian was to be injured by a horse or vice versa.

Chair Hake requested that his item be brought back to the next meeting as an official agenda item to discuss the concerns by the Commissioners.

BC Brown agreed to bring back more information the Commissioners at the next meeting.

Commissioner Balys had nothing to report.

Commissioner Hake had nothing to report.

Commissioner Christensen had nothing to report.

Commissioner Migliore had nothing to report.

Commissioner Grady proud to announce that this is his eleventh year serving on the DAC Commission. In his eleven years on the Commission he has seen that parks have grown with much more recreation, and he feels as though recreation is getting all of the attention which in turn the older park are being neglected. Has requested if this issue could possibly be address in the specific plan, so that they are not being neglected. Visited Mayflower Park three this year and all three times he damaged his boat and trailer due to the ramp being too short.

Commissioner Van Horn was in Ojai and visited a trail that goes from Ojai to Ventura. The trail is being used by skateboarders, horses, walkers and bike riders of all ages, thought that was very cool see.

CM Van Horn announced that he was reappointed to the District Advisory Commission for a new term.

Commissioner Rosen noted that the tentative trails map was approved by the Wine Country Ad-Hoc Committee, and since then was also been approved by the County Trails Committee on February 25, 2015, and by the District Advisory Commission on May 7, 2015.

CM Rosen also mentioned that the State Secretary of Agriculture has denied the County's request for creating a ban on wood chip. Firewood and mulch coming into the County from contaminated areas around us.

CM Rosen attended the Flowrider dedication to Charlene Busch at the DropZone Waterpark. CM Stated that the Supervisor is now talking about the next addition to the Waterpark, which he believes, should happen every 1 to 2 years.

Lastly, CM Rosen stated that Supervisor Ashley has asked the District to look into the possibility of creating an RV Park next door to DropZone Waterpark.

Commissioner Zimmerman stated he looks forward to working with the District Advisory Commission. CM Zimmerman would also like to work towards retaining some local water polo teams to be able to use the Dropzone Waterpark.
